

DESCRIPTION: SK-831 is a carmel-brown, liquid, concentrated liquid cleaner. It is a foaming product and can be used in a wide variety of conveying, tracks, or shackles. **SK-831** should be diluted with water for use. Dilution rates will vary. **SK-831** is **Flammable** in liquid and vapor form.

SK-831 is designed for use on metal or plastic surfaces: this product may be used to clean food processing plants that have chains, tracks, or shackles that need cleaning. Dilution rates will vary.
